

Thanks for making 2016 a banner year!

In 2016 we raised \$17,700 in our fund raiser, including a \$9,905 grant, distributed 1,000 books, had 1,800 course graduations, trained 120 leaders, started ministries in 12 new locations, upgraded all books to new professional format, updated the Dating and Marriage course, updated the curriculum, completed the work for the new Handling Loss and Grief course as a joint project with the Living Free ministry, updated and expanded the Financial course, completed most of the work for the new Change of Heart course, and upgraded all FIT courses to the nine-lesson format.

Though a trying year, we came out stronger than ever. Because of the outstanding support received through the board in terms of personal financial sacrifices, the more than record amounts raised through the fund raiser, and the faithful support of others, we made it. The year started out as our most difficult time financially with having to borrow money for the first time in ten years. It ended in the black with the largest inventory of books we have ever had. Thank you and thank God.

FIT Moves Beyond Florida

In a growing trend, the FIT program is moving beyond its roots in Florida. A number of our board members are moving out of state and have stated their intentions of taking the program with them. We also have “snow birds” also facilitating in Florida in the winter and in their home states in the summer. FIT is also working with the Living Free ministry in Chattanooga, TN in revising their Handling Loss and Grief course.

Keep your Dues Up-to-Date

Keeping current on your dues is essential to our program. We provide many services to many ministries and our minimal dues (\$25 per year) helps us in several ways. It helps us update our contact lists, pay the bills, and determine who gets our free materials. Even though our writers write for free, there are still production costs. We have only one paid employee to run the office and we can only afford to pay her for 20 hours a week. Most ministries and facilitators cannot afford to buy our books and custom-made, central database-generated certificates and we end up providing them for free.
