• We're still here

Chris is also training to of the chaplains at the facility to conduct courses.

Inspirational Note from FIT Trainer and Board Secretary Dr. Joe Sheehan.

Last year, an inmate in for murder told my class this story. His sister had been raped and murdered 8 years prior. His life has been consumed by hate and rage ever since. "I forgave the guy this morning and have real peace about it," he said.

That deliverance wouldn't have taken place without FIT. Only a handful of social outcasts know the story. But there's a God in heaven who knows and He never forgets.
